



Tesla Rental Contract – Addendum

This is the addendum to the Tesla Rental Contract (“the Contract”) and should be read in conjunction therewith. The terms set out in this Addendum form part of the Contract. If there are any contradictory terms between the Contract and the Addendum, those in the Contract shall prevail.

- Our Tesla electric vehicles (EV) have a standard battery capacity and range; however, the performance of that battery depends on the conditions under which it is operated. Grace Bay Car Rentals will not be liable or responsible for any shortfall in the battery capacity or range.
- The Battery charging limit on your EV rental is set at 80% and should be left at this limit. Adjusting the battery charging limit to 100% can lead to significant battery degradation which is not covered by the Loss Damage Waiver (LDW)
- Your EV comes with a 3-piece charging kit. It is important to look after the cables and parts, and ensure they are all returned, undamaged with the vehicle. The cost for replacement cables is approximately \$750 each and this will not be covered by the Loss Damage Waiver.
- Any undercarriage or battery damage caused by driving over foreign objects, or exceeding the charging limits, is not covered by the Loss Damage Waiver
- A key card will be provided for the EV. Please take good care of this keycard and ensure it is returned undamaged with the vehicle. The cost for damaged or replacement keycards is \$350, which is not covered by the Loss Damage Waiver
- A Blink charger key card will be provided which can be used to access complimentary charging at the Grace Bay Car Rentals Grace Bay location. The cost for damaged or lost Blink keycards is \$100, which is not covered by the Loss Damage Waiver
- Basic Roadside assistance is provided with the vehicle. It will not cover incidents for which you are at fault (ex. Running out of electricity, lost/damaged keys, etc.)
- For your safety, mobile tracking is enabled, and the EV vehicle speed is limited to 80km/hr (50mph). Tampering with any of these settings, and/or driving in any prohibited way will null and void any LDW. Prohibited features include autosteer and autopilot, and adjustment of the preset speed limit and charging limits.
- Grace Bay Car Rentals will not be responsible for removing any personalization created in the electric vehicle. For example, if you sign into Netflix or Spotify, then you are responsible for logging out at the end of your rental. Grace Bay Car Rentals is not responsible if you fail to log out and another renter utilizes your account.
- The electric vehicle should only be washed at an approved Grace Bay Car Rentals location. Any damage that occurs from unauthorized washing of the EV is not covered by the LDW, and you will be liable for all costs associated with this prohibited use.
- Daily rental rates do not include the cost of electricity required to charge an electric vehicle. Grace Bay Car Rentals (GBCR) will endeavor to provide our electric vehicle with a minimum charge rate of 40-60% and ask that you return the vehicle with the same charge level as was provided at departure, or an EV Battery Recharging Service Fee will be added. In addition, A Low Battery Recharging Service fee will be applied to any EVs returned with less than 10% charge. *Note – complimentary charging is available at the blink stations located at the GBCR Grace Bay Location as per below.*

Recharging Your EV

Complimentary charging is provided at the Blink charging station conveniently located at the Grace Bay Car Rentals Office in Grace Bay. A Blink charger access card is provided with your rental. The costs associated with **charging at any location** other than GBCR blink stations (ex. Villa/resort, public charging station, etc.) are the full responsibility of the lessee. Any third-party invoices directed to GBCR for charging will be processed to the credit card provided upon rental.

If you return the EV at a **lower charge rate** than the battery departure level:

- You will be charged the EV Battery Recharging Service fee to bring the EV back up to the battery departure level; and
- If you return the vehicle at less than 10% battery level, an additional Low Battery Recharging Service fee (equivalent to one day rental) will be applied **Any applicable charges will be processed on the card provided.*

I authorize Grace Bay Car Rentals and Sales Ltd. to charge my credit card for any and all damage occurring during the contract period including any extension period to the rental agreement I request or for any unauthorized rental taken beyond that for which I have contracted.
